Contestants meeting and block draw at 11:30, Show starts at 2:00 pm.

Powersaw Tree Falling. Sign-up for this event at “Check In.” **You must be present to sign up.** Entry fee is \$20 cash. 20 positions are available. Spots will be filled at the contestants meeting by random draw by the pool of contestants. Prize pay-out is as follows: 1st - 50% of pot, 2nd – 30% of pot, 3rd 20% of pot.

Chopping Events. Cottonwood or alder. **Entries may be limited based on available wood. Get your entry in early!** You may only register for one underhand category. Springboard may be limited to the first 12 entries received.

Sawing Events. Cottonwood or white pine.

- Powersaw bucking will be “Cold Start.” Production chainsaws 140cc or less only.
- Contestants must provide their own cross-cut saw for hand sawing events. Please specify if you are sharing a saw with another contestant.

Sign up for **Wrapper Throwing** and **Trailer Backing** on the day of the event.
Unlimited Hotsaw will be exhibition only.
